




Quarterly Financial Results Q1 - Q3, 2022






Consolidated Financial Results Q1 - Q3, 2020 - 2022





Revenues Classified by Area Q1 - Q3, 2022


Q1-Q3, 2022 Consolidated Revenues: NT\$1,216 million






